

Journal of Aid-in-Dying Medicine (the Journal): General Guidelines and Conditions:

- **Originality:** Articles must be original in their entirety, or a clearly stated adaptation of a previously published article(s) that has been reformed/restructured for the Journal of Aid-in-Dying Medicine (the Journal). Articles must not be under consideration for publication elsewhere and, if accepted by the Journal, will not be published elsewhere in the same or significantly similar form.
 - The authors must have all necessary permissions for works not owned by them, including illustrations and tables.
- **Multiple Authors:** If there are multiple authors, a Corresponding Author must be selected. Consent from all listed authors must be obtained by the Corresponding Author before submitting the article to the Journal.
- Please review our **Language and Formatting Guidelines** before submitting your manuscript.
- **Article types** (for inclusion in the peer-reviewed sections of the Journal, i.e. investigations and analyses; this does not include, for example, poetry, artwork).
 - Abstract: An abstract of 250 words or less must be included with each submission.
 - 2 to 8 keywords should be included.
 - Original research/investigations: 3,000 words or less (not including the abstract and authors' information).
 - Opinion, commentaries, editorials, analyses: 2,000 words or less (not including the abstract and authors' information).
- **Funding:** All authors must acknowledge any funding related to the investigation and/or writing of the article.
- **Conflict of Interest:** All authors must declare and list any real or potential conflicts of interest. This will be noted at the end of the submitted manuscript. If there are no conflicts of interest, a declaration should be included, stating, "The author(s) declare(s) that there is no conflict of interest."
- **Peer Review:** Relevant submissions will be initially assessed by the First Review Committee for suitability for the Journal. Papers deemed suitable are then typically sent to a minimum of two independent, anonymous, expert peer reviewers to assess the quality of the paper and appropriateness for the Journal. Authors may be asked to respond to comments and questions from the peer reviewers, who will remain anonymous. The Editor in Chief, at times with advisement from the Editorial Board, is responsible for the final decision regarding acceptance or rejection of articles. Once an article is accepted for continued review and editing, it will be assigned to a particular

editor for further development. The Journal is not committed to publishing an article until the author, editor, and Editor and Chief have agreed to the final version. The author(s), Editor, and Editor in Chief will work diligently to agree on a final version of the article, but if no such agreement can be reached the Editor in Chief can decide not to publish the article. The authors may then submit the materials to other publications.

- **Journal Staff Conflicts of Interest:** The Editor in Chief, members of the Editorial Board, and individual Journal editors cannot be involved with papers they have written themselves or have been written by family members or colleagues, or which relate to products or services in which those individuals have an interest. Any such submission is subject to all of the journal's usual procedures, with peer review handled independently of the relevant staff members.
- **Plagiarism:** The Journal takes all acts of plagiarism and/or copyright infringement seriously, and reserves the right to retract a published article and/or publish an "erratum" in a subsequent edition of the Journal.
- **Copyright:** Upon acceptance of an article, authors will be asked to complete a 'Journal Publishing Agreement.' Since the Journal of Aid-in-Dying Medicine is an open access, no paywall publication intended for widest dissemination of educational materials, authors will be free to reproduce their articles published in the Journal, but only if they clearly and prominently cite the origin of the publication as the Journal of Aid-in-Dying Medicine.
